# **Agreement Planning, Policies and Regulations of the Friendship Missionary Baptist Church**

## **RENTAL FEES**

- A security deposit/down payment of \$100.00, along with this signed agreement, is required to reserve the date(s) and space. The security deposit/down payment of \$100.00 will be applied to your total rental fee. All balances must be paid to Friendship Missionary Baptist Church (FMBC) 10 days in advance of event by either cash, money order or certified check. No personal checks will be accepted unless a church member has reserved the facility. No hold dates or terms will be granted until the security deposit is received.
- The normal contractual agreement hours for events is based on 0-6 hours and may occur only in the space rented by the Renter/Guest. Arrangements regarding activities beyond the 6 hours or in areas not rented will be subject to addition personnel fee and space charges.
